ORDER:

In the reference 10th cited certain PETs and equivalent cadres, Class-II of APSESS working in prakasam district were promoted temporarily under 10(a) of AP State and Sub-ordinate service Rules-1996 on adhoc basis and posted to certain posts of School Asst.(PE) Govt. Management fallen vacant due to up gradation of PETs in the district on adhoc basis which are treated as vacancies . They are promoted subject to review at future date depending on the final outcome of the court cases and Govt. order

At present in the reference 11th cited, the Govt. have issued orders under rule 13(g), that upgraded posts of school Assts (Languages and Physical Education) as per GO.MS.No.144, Finance Department, Dated:02.08.2016 and also posts of Gr.II Head Master due to filling up of MEO posts in the State on adhoc basis shall be treated as vacancies. The effected persons (excluding promotes) should participate in the transfers counseling with entitlement points applicable to their previous stations. Those who got adhoc promotions shall attend regular promotion counseling after completion of transfer counseling process.

Hence after conduct of Teachers transfers counseling to School Asst.(PE) working in Govt. Management on 25-07-2017, after arising resultant vacancies, School Asst(PE) Promoted in the reference 11th cited on purely temporarily basis are hereby transferred and posted as School Asst(PE) as per the options given by them to High schools mentioned against their names in the annexure appended.

The Headmasters concerned are instructed to relieve and admit the School Asst(PE) now transferred immediately. The dates of relief and joining shall be reported promptly.
